Remark:

1. Graduation requirement: 43 credits for Bachelor and 36 credits for IMBA with Financial and Economic Law emphasis (FEL emphasis). Senior students in dual degree program can take master's courses at the same time.

2. Students are required to study designated courses for 6 hours through the online platform of the “Center for Taiwan Academic Research Ethics Education (AREE)”, and can apply for the master degree examination only after reaching the passing standard in the overall test of the course.
3. International students of Asia University taking English courses in the field of liberal arts are required to follow the curriculum regulations set forth by the Center for the Development of Language Teaching and Research.
4. To be qualified for graduation, international students are required to take and pass one Chinese course by the Center for the Development of Language Teaching and Research.
