1. 本課程規劃適用於本學系 115 學年度入學學生，准本系其他學年度入學學生，除已規劃之學分數務必修習外，不足 128 之畢業學分，亦可選修本規劃之專業課程列入其畢業學分中。
1. This course plan applies to students enrolled in the 115th academic year of the department. However, students enrolled in other academic years of the department, in addition to the planned number of credits must be taken, less than 128 graduation credits, can also choose to take the professional courses in the plan to be included in their graduation credits
2. 學生應修畢 128 學分（含）以上始能畢業，其中應含「校定課程」30 學分；「院核心課程」15 學分；「系核心課程」54 學分；112 學年度開給財法系不分組，可由學生自行選擇兩個學舉內的課羣，滿總學分即可畢業。若要在畢業證書註記單一學程，必須修完該學程全部課程 20 學分，不足之學分數則可選修本系專業選修學程或本系實務選修選修課程（不含校定必修、體育（五）及體育（六）），以補足 128 學分。
2. Students shall complete at least 128 credits (inclusive) for graduation, including 30 credits of " University Required Credits", 15 College Core Courses ", and 54 credits of " Departmental Core Courses "; the Department of Finance and Law will not be divided into groups starting from the 112th academic year, so that students may choose two courses within the curriculum on their own, and will be able to graduate if they have completed a full set of credits. Students who wish to register a single program on their ' diploma must complete 20 credits of courses in that program. If the number of credits is insufficient, students may take elective courses in their major or other elective courses in their major (excluding the required courses of the university, Physical Education (5) and Physical Education (6)) to make up the 128 credits. Students who have not taken General Principles of Civil Law may not take General Theory of Debt in Civil Law, Various Theories of Debt in Civil Law, Property Rights in Civil Law, Civil Procedure Law, and Civil Legal Practice first, but with the consent of the instructor, this restriction does not apply.

(4)實習時數以每日不超過 8 小時、每週不超過 40 小時為原則。

14. The number of internship hours and credits for the streaming internship program (7+ 1 system) shall be in accordance with the following regulations:

(1)Each internship credit shall be based on a minimum of 60 hours and a maximum of 80 hours.

(2)The total number of credits per semester shall not exceed 9, with a maximum of 720 hours.

(3)Internship credits counted toward graduation requirements shall be limited to a maximum of 18 credits, not exceeding 1,440 hours in total.

(4) Practicum hours should not exceed 8 hours per day and 40 hours per week.
