一、碩士班最低畢業學分：

甲組(法律學組)為 36 學分(含論文)：(一)校定必修 3 學分：碩士論文。(二)所定必修 5 學分。(三)所定選修課程 28 學分(其中含必選一型分流課程 2 學分)。(四)於畢業前參加研討會 1 場或發表期刊論文 1 篇。

乙組(法律專業組)為 36 學分(含論文)：(一)校定必修 3 學分：碩士論文。(二)所定必修 5 學分。(三)所定定選修課程 28 學分(其中含必選一型分流課程 2 學分)。(四)補修大學部法學專業課程至少 24 學分。(五)於畢業前參加研討會 1 場或發表期刊論文 1 篇。

1. The minimum number of credits for mater degrees:36 credits for Group A (the Science of Law Program) (including the master thesis): (1) 3 credits of university required courses:master's thesis (2) 5 credits of department required courses (3) 28 credits of required elective courses (including 2 credits of requiredstream 1 courses). (4) Participate in one seminar or publish one journal article before graduation. 36 credits for Group B (law program) (including master thesis): (1) 3 credits of university required courses: master's thesis (2) 5 credits of department required courses. (3) 28 credits of required elective courses (including 2 credits of required stream 1 courses). (4) A minimum of 24 credits of undergraduate law program. (5) Participate in a seminar or publish a journal article before graduation.

二、抵免學分者，須通過抵免規定後，方得提出論文口試。

2. Students who apply for credits exemption must must pass the exemption regulations before submitting the oral examination for thesis.

三、為符合高教「課程分流」趨勢，碩士班甲組及乙組研究生於畢業前，至少應修畢「研究型」、「實用型」二所定分流課程其中之一；跨分流課程所修之學分，仍得列為系定選修學分。

3. In order to comply with the trend of “program diversification” in higher education, graduate students of Master's Program A and B should complete at least one of the two designated diversified courses, namely, “Research” and “Practical”, before graduation; the credits of the cross-diversified courses can still be regarded as departmental elective credits.

四、為落實學用合一，畢業門檻訂有專業實習(諮詢服務)要求，研究生於畢業前應至法律專業事務所實習 40 小時以上，或由指導教授協助至法律扶助基金會參與法律諮詢服務及其他經系上認可之實習活動合計 40 小時以上，有證明文件。

4. To realize the integration of learning and application, there is a professional internship requirement for graduation. Graduate students should intern in a law firm for at least 40 hours before the graduation, or participate in legal consulting services at the Legal Aid Foundation with the assistance of their supervising professors, or participate in other internships recognized by the department for at least a total of 40 hours. with supporting documents.

五、為強化分析與問題解決能力，早期提供研究之具體建議，研究生應先完成碩士論文計畫書公開發表會，方得提出論文口試。

5. To strengthen analytical and problem-solving skills, and to provide a concrete proposal for research at an early stage, graduate students should complete a public presentation of their master's thesis proposal before they are allowed to submit it for an oral examination.

六、碩士班乙組研究生應補修大學部法學專業課程 24 學分以上：其中必修課程 15 學分為：民法 6 學分(民法總則、民法債編總論、民法債編各論、民法物權、親屬法、繼承法中之課程合計 6 學分以上)、刑法 3 學分(刑法總則、刑法分則中之課程 4 合計 3 學分以上)、民事訴訟法 3

學分、刑事訴訟法 3 學分；其餘 9 學分，可選擇從本校或他校於下列法學專業課程中選修：商事法(公司法、票據法、海商法、保險法、證券交易法及期貨交易法規中之課程)、行政法(行政法總論、行政救濟法規、公法實務與專題研究中之課程)、國際私法、國際公法、強制執行法、非訟事件法、仲裁法、公證法、破產法、少年事件處理法、證據法、土地法、租稅法、公平交易法、智慧財產權法、著作權法、專利法、商標法、消費者保護法、社會福利法、勞工法或勞動法、環境法、國際貿易法、英美契約法、英美侵權行為法、法理學等學科。

6. Graduate students in Master's Group B should take at least 24 credits of law courses: 15 credits of required courses: 6 credits of civil law (6 credits or more of courses in the General Principles of Civil Law, General Theory of Civil Law, Various Theories of Civil Law, Civil Law of Property, Law of Relatives, and Law of Inheritance), 3 credits of criminal law (3 or more credits of courses in the General Principles of Criminal Law and Sub-principles of Criminal Law), 3 credits of civil litigation, 3 credits of criminal litigation; the remaining 9 credits can be chosen from the following law courses at this or other universities: commercial law (corporate law, bills law, maritime law, insurance law), commercial law (corporate law, bills law, maritime law, insurance law, insurance law). The remaining 9 credits can be selected from the following law courses offered by this university or other universities: Commercial Law (courses in Corporate Law, Bills of Exchange Law, Maritime Law, Insurance Law, Securities and Exchange Law, and Futures Trading Law), Administrative Law (courses in General Administrative Law, Administrative Law of Relief, and Public Law Practice and Special Topics), Private International Law, Public International Law, Compulsory Enforcement Law, Non-Contentious Matters, Arbitration Law, Notary Public Law, Insolvency Law, and International Law. The courses include: International Private Law, International Public Law, Enforcement Law, Non-Contentious Law, Arbitration Law, Notary Public Law, Bankruptcy Law, Juvenile Justice Law, Evidence Law, Land Law, Rent Law, Fair Trade Law, Intellectual Property Law, Copyright Law, Patent Law, Trademark Law, Consumer Protection Law, Social Welfare Law, Labor Law, Labor Law, Environmental Law, International Trade Law, Anglo-American Contract Law, Anglo-American Tort Law, and Jurisprudence.

七、碩士班乙組研究生抵免補修學士班法律課程，以曾在各大學法律相關學系，修畢其法律專業課程學分，經系主任或諮請相領域課程教師認定同意抵免者，方可辦理抵免。

7. Graduate students in the Master's Group B can apply for credits exemption from bachelor's degree law courses only if they have completed legal course credits in law-related departments of universities and have been approved by the department director or consulting course teachers in the relevant field.

八、學生需透過「臺灣學術倫理教育資源中心」線上平台修習指定課程 6 小時，並於課程總測驗成績達及格標準，始得申請學位考試。

8. Students are required to take 6 hours of designated courses through the online platform of the Taiwan Academic Ethics Education

Resource Center (TAEERC) and achieve a passing grade on the overall course test before applying for the degree examination.
